

Warranty and Limitation of Liability

The operation and performance of thermal control devices including thermostats, Thermal cut-offs (TCO's) and electric heaters provided by Comstat are inherently application specific. Purchasers are advised to test and engineer their products and the application of Comstat components. Whenever Comstat provides analysis or information to assist the purchaser in the application of Comstat components, such analysis or information shall not affect any of the foregoing nor shall it consitutue a warranty of any kind with respect to said application. All purchasers shall remain responsible for dissemination of product safety information to their customers and ultimate users of their goods containing Comstat's products.

Comstat warrants its Products against defects in material and workmanship for at least one (1) year from the date of delivery, provided such Product is properly applied, used and maintained. Comstat does not warrant any Product against damage from corrosion, contamination, misapplication, improper specification or wear and tear and operational conditions beyond Comstat's control. The terms of this Warranty are the exclusive terms available to Buyer and to any other person or entity to whom Products are transferred during the period of this Warranty. No person has authority to bind Comstat to a representation or warranty other than this express Warranty. Comstat shall not be liable for incidental or consequential damages resulting from the use of Products whether a claim for such damages is based upon warranty, contract, negligence or other cause of action. Should any Product fail while subject to this Warranty, such Product shall be repaired or a substitute Product shall be provided, at Comstat's option, at no charge to Buyer or to any other person or entity to whom Product is transferred during the period of this Warranty. Comstat must be notified of the alleged failure of Product within thirty (30) days of such event and advanced authorization for repair or replacement must be obtained in writing from Comstat.

THIS WARRANTY IS MADE EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY WARRANTY ARISING FROM A COURSE OF DEALING OR USAGE OF TRADE, AND ALL OTHER SUCH WARRANTIES ARE SPECIFICALLY EXCLUDED. THE CORRECTION OF ANY DEFECT IN OR FAILURE OF PRODUCTS BY REPAIR OR REPLACEMENT TO THE EXTENT SET FORTH ABOVE, SHALL BE COMSTAT'S LIMIT OF LIABILITY AND THE EXCLUSIVE REMEDY FOR ANY AND ALL LOSSES, DELAYS OR DAMAGES RESULTING FROM THE PURCHASE OR USE OF THE PRODUCTS. IN NO EVENT SHALL COMSTAT BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES. COMSTAT SHALL NOT BE LIABLE FOR, AND BUYER AND ANY OTHER PERSON OR ENTITY TO WHOM PRODUCTS ARE TRANSFERRED DURING THE PERIOD OF THIS WARRANTY ASSUMES RESPONSIBILITY FOR, ALL PERSONAL INJURY AND PROPERTY DAMAGE RESULTING FROM OR RELATED TO THE HANDLING, POSSESSION OR USE OF PRODUCTS AND PRODUCTS MANUFACTURED AND SOLD BY COMSTAT HEREUNDER.
